The Walled City of Lahore Authority – WCLA (the “Employer”) intends to E-Tendering for the following project through newly introduction E-Procurement / EPADS.

1. All Contractors who are registered with Pakistan Engineering Council (PEC) at least mentioned below category and specialized code **EE04, EE06**, having relevant experience of **Electrical projects** can participate in Open E-Procurement / EPADS system. Procurement procedure strictly be adopted in accordance with PPRA Rules 2014 (with up-to-date amendments). Contractors can participate in E- procurement / EPADS after fulfilling following terms & conditions.
2. Contractor may register firm on website EPADS / <http://eprocure.gov.pk> of Public Procurements Regulatory Authority (PPRA) by submitting their requisite information. After registration on E-Tendering website **EPADS / <http://eprocure.gov.pk>** contractor of eligible categories may participate in E-Procurements.

3. Single Stage Two envelopes bidding procedure shall be adopted. Contractor / bidder has to upload scanned copy of technical bid and financial bid Along with CDR on EPADS on or before **10.04.2026**, not later than **11:00 AM**. The opening of Technical bid is on same date at **11:30 AM**. Manual Bids shall not be accepted.
4. The contractor shall obtain the Bid Security, from any scheduled bank of Pakistan. The original Call Deposit Receipt (CDR), made in favor of the **Director General, Walled City of Lahore Authority (WCLA)**, must be submitted to the undersigned on the tender opening date **prior to the closing time**. Failure to submit the original CDR within the prescribed timeframe shall result in **disqualification of the bidder** in the presence of the Tender Opening Committee.
5. In case of false information, fake Bid Security (CDR), the contractor will be liable to disqualify as per PPRA Rules and will not be eligible to participate in opening tender of WCLA, Government of the Punjab. Further his case will be forwarded to PEC and PPRA for initiation of Strict Legal Action.
6. The Bid document comprising Proposal prepared in accordance with instructions in bidding document shall be uploaded on E-PADS on or before 10-04-2026 by 011:00 AM (As per PPRA rule 14 sub rule (3) response time is calculated from the date of publication on website of authority <https://walledcitylahore.gov.pk/>, URL of the advertisement on website of authority. The URL of the website of the PPRA is (<http://eproc.punjab.gov.pk/View/Tender.asp>) and response time shall be calculated exclusively from the date of publication of the advertisement on the website of the PPRA. This advertisement is already uploaded on PPRA website on 11th March 2026. Technical Bids will be opened on same day at 11:30 AM by the committee in presence of the bidders / their authorized representatives and financial bid will be opened after Technical Evaluation.
